

THE BILL COCHRAN AWARD
For service above self of the
OREGON SOCIETY OF TAX CONSULTANTS

Bill Cochran was an Oregon Licensed Tax Consultant, who lived in the Green District of Roseburg, Oregon. He was originally employed as an accountant for a Roseburg trucking company and had his tax practice in the Roseburg area.

Bill was elected as State Vice President for the 1976-77 fiscal year, and was reelected to the office for a second term for 1977-78 years.

He became O.S.T.C.'s fourth President for 1978-79 when the organization was holding its unit meetings at Terry's Café in Rice Hill, Oregon. Although other areas were forming units of the Association, the primary, monthly meetings were scheduled in the Douglas County area.

Bill was a mild-mannered man who did not express strong emotions, but quietly went about doing his job as President of the Association. He was well organized and very conscientious in managing the affairs of the Association during this pending period of growth of the organization.

His dedication to O.S.T.C. became apparent when he was diagnosed with cancer midway during his term of office. He underwent chemotherapy treatments at Sacred Heart in Eugene, Oregon. As an example of Bill's tenacity and dedication to his office in O.S.T.C., he would go to Eugene for chemotherapy, and then attend the Association meeting the same evening during which it was apparent to all that attended the meeting that he was in great pain, but passed it off as inconsequential. He did not miss a single meeting during the time of therapy sessions.

Although, Bill never really recovered from his malady, he displayed a great spirit and proved to be a real fighter, in spite of his benign attitude. He gained the admiration of every member of the Association who knew him personally.

Following his term of office as President of O.S.T.C., Bill did not slow down, but continued to serve the organization wherever he was needed. He did take time to take a vacation trip to Greece in 1980 where he succumbed to his cancer. Bill was only in his 50's when he died, and the Board of Directors of O.S.T.C. was so IMPRESSED WITH HIS DEDICATION to the Association and his fighting spirit, which so exemplified the tenants of O.S.T.C. that the Bill Cochran Award for meritorious service above self to the Association was created, and has been awarded annually since its inception to a worthy member recipient.
